The City of Lethbridge and our partners at the University of Lethbridge's Prentice Institute for Global Population and Economy, Lethbridge College, and of course our students, are looking forward to hearing your unique insights, experiences, and contributions. This information package provides an overview of the PIL to assist you in preparing your upcoming presentation.

What is the PIL?

The 2024 Policy Innovation Lab (PIL) is a four-week experiential learning opportunity that focuses on the complex interconnections between of Urban Food Security, Policy, and Land Use.

Over the month of May 2024, six undergraduate students, three each from the Lethbridge College and the University of Lethbridge, will participate in a seminar series to build their understanding of food (in)security, policy, and land use planning.

Working in collaboration, this diverse cohort of students will apply their lived and learned knowledge to conduct research, analyze policy interventions and make recommendations to address food insecurity within their community.

The students' work will contribute to the City of Lethbridge's Land Use Bylaw (LUB) renewal project.

What are the PIL's goals?

The PIL intends to create a **knowledge bridge** between the City of Lethbridge, post-secondary students, post-secondary institutions (PSIs), and other community partners to understand and **respond to shared challenges**.

The City, Prentice Institute and College have worked together to recruit students to participate in this policy "bootcamp" with the aim of producing a **technical research report** that proposes food security interventions through land use policy updates.

In the PIL, students will attend seminars, presentations, field trips and professional development sessions allow them to **activate existing academic knowledge** within an applied environment, **learn new skills** and **leverage lived experience**.

Additionally, the PIL will help the City, College, and University to explore, grow, and innovate new models for workintegrated and experiential learning.

The City of Lethbridge (Sikóóhkotok) is located in the Territory of the Blackfoot Confederacy (Siksikaitsitapi) Nations. Lethbridge is also home to the Métis Nation of Alberta Region 3.

City of Lethbridge Land Use Bylaw Renewal

The City of Lethbridge is undergoing a renewal process for its Land Use Bylaw (LUB). As one of the primary policy instruments used to manage land use in the city, the LUB creates a lasting impact on the spatial distribution of economic, social, residential and other activities. Given the long-term presence of the city's built environment (e.g., schools, houses, roads), the policies and regulations contained in the LUB are quite impactful.

The LUB renewal presents an opportunity to identify and reflect on the current spatial distribution of land uses, including those that directly relate to food production, distribution, sale, and access.

For example, the LUB can potentially address concerns such as food deserts and the location of key support services like food banks.

The Sustainable Development Goals as a Lens for Food Insecurity

The PIL's theoretical lens to explore food insecurity aligns with United Nation's (UN) Sustainable Development Goals (SDGs). In 2015, the UN created the 17 interconnected calls to action (the SDGs) to improve peace and prosperity globally.

Framing food insecurity using the SDGs provides students with several points of entry for sustainable solutions to complex topics, such as hunger, inequality, justice, and partnerships.

This allows students with different lived experiences and academic backgrounds the opportunity to connect to the topic of food security, and the interconnected issues in diverse, intersectional, and impactful ways.



Deliverables for the PIL

Seminar Attendance & Leadership

Students are expected to attend all the seminars unless there are extenuating circumstances. While attending, students are expected to participate fully, including reviewing supplementary reading materials in advance of sessions, and being engaged in conversations. You are also expected to contribute to a positive learning and knowledge sharing environment between yourself and your peers, the PIL hosts, presenters, and other participants.

Interim Presentation | May 23, 2024

The interim presentation is an opportunity for students to receive formal feedback on their research report from City staff and faculty. The student can then incorporate the feedback into the final report. The presentation should take the form of a powerpoint presentation (or similar) highlight the key aspects of the written paper.

Final Research Report | May 31, 2024

The final research report is the main focus of the PIL. City staff will use the report to engage with the topic of food security in the broader context of the LUB Renewal Project, including evaluating potential recommendations for policy change. The main components of the report include:

- Local Experience
 - What is food security?
 - From an intersectional lens, what is the community need with respect to food security?
 - Mapping or other illustrative tool that describes the current state of food (in)security in the city, including at its various "scales" (e.g., neighbourood level, demographic level).
- Potential Policy Approaches
 - Case studies / best practices from other municipalities
 - Potential policy approaches that can be taken in the new LUB

If there is time, students can also explore:


- Food and the LUB
 - How does the LUB impact the location/availability/accessibility of food within the city?
 - How is food considered by each of the City's different Land Use Districts?
 - Where is food typically available today? What kinds of land use definitions to these uses fall under today (e.g., convenience store, retail store, restaurant, soup kitchen)?
 - How difficult is it to get approval for creating new instances of these uses (e.g., zoning and/or development approvals)?
 - Are there rules in the current LUB that tend to (perhaps unintentionally) create food deserts in the City? (e.g., auto-centric development paradigm)
 - Are the concerns that people, businesses or other stakeholders might have with changes to how food-related uses are considered in the LUB?

The academic poster is a supplement to the final report, summarizing the project for a public audience. Additional information and templates will be provided.

Students will be asked to participate in the evaluation of the PIL at its conclusion.
